



# How Wangchuk shot to limelight as a political provocateur

Srinagar: Phunsuk Wangdu, the protagonist of the cult 2009 film *3 Idiots*, would famously work his way out of trouble with 'All Izz Kaun'... Ladakh's Sonam Wangchuk... the inspiration behind the endearing character essayed by Aamir Khan, has since gained a reputation more as a political provocateur than a proponent of philosophical life hacks.

Wangchuk, variously described as an innovator, activist and climate warrior, did not stumble into politics overnight. Four months after the abrogation of Article 370 in Aug 2019, he released a video thanking PM Narendra Modi for making Ladakh a Union Territory... "People here have started asking why their UT status was granted to exploit Ladakh's vast resources, and whether our resources will be exploited the way China does in Tibet," Wangchuk said.

In Jan 2023, he announced a five-day climate strike at Leh. He led the highest, where winter temperatures plunge to minus 40 degrees Celsius. The administration prevented him from reaching the site, forcing him to pitch tent in Leh instead. The protest was Wangchuk's mission. In Oct 2024, he ended another 16-day fast only after the Union home ministry agreed to resume talks with Ladakhi organisations.

After negotiations stalled, he launched a new 35-day hunger strike on Sept 10 this year, demanding the scrapping of Ladakh's Sixth Schedule safeguards. "It's possible that we might die. If we survive, we will return for another hunger strike of six weeks," he declared. Last Wednesday, he called off another violent protest, disrupting the region.

Born in 1966 in a village near Leh, Wangchuk had been homeschooled until he was nine. In 1975, after his father Sonam Wangchuk became a minister in the then J&K Govt, the family moved to Srinagar. He later studied engineering at NIT Rourkela and got another degree from CRATeE School of Architecture in Grenoble, France. In 1988, Wangchuk co-founded the Students' Educational and Cultural Movement of Ladakh to reform the education system.

Both supported Wangchuk's campaign. In 2019, he was elected to the Ladakh Autonomous Hill Development Council. He later formed the Ladakh Democratic Alliance, which won 10 seats in the 2020 local polls. He later formed the Ladakh Democratic Alliance, which won 10 seats in the 2020 local polls.

Ladakh institutions ordered shut for two days. Chering Dorjay Lakruk, co-chairperson of Leh Apex Body, termed the allegations against Wangchuk baseless. "I am sure that on Sept 23, LAB-affiliated Apex Body Youth called for a shutdown after two people fasting alongside Wangchuk collapsed. About 7,500 protesters gathered the following day. They later hurled stones at the Ladakh Autonomous Hill Development Council office, leading to the mayhem in which four died."

He said that despite setbacks, Ladakhis would go ahead with the scheduled Oct 26 talks with an MHA-appointed committee. The delegation will travel to Delhi on Sept 30. In New Delhi, opposition parties condemned Wangchuk's arrest, with Congress calling it Modi gov't's action to "divert attention and responsibility" to maintain law and order. It also published claims that its Ladakh councillor Phuntsok Stanzin Tsapag was involved in Wednesday's arson.

# Bought rights to Ilayya songs: Sony

From P1. Prompting the plea, Justice N. Senthil Kumar directed Sony to file its counter by Oct 22 and furnish day-to-day revenue collected from exploiting Ilayaraja's works. Senior advocate S. Prabhakaran, representing the music director, submitted that to date, no person or entity has produced documentation or legal basis to establish that Ilayaraja parted with the title, ownership or any aspect of his rights in his original musical works.

Hence, Sony is commercially exploiting Ilayaraja's musical works in more than 300 films through digital platforms without complying with the Copyright Act, which mandates equal sharing of royalties with the original creator, the counsel argued. "Ilayaraja is reliably given to understand that Sony is generating substantial revenue from such digital exploitation," Prabhakaran said. Apart from this, Sony has been publishing, modifying, mutilating, adapting, and remastering the composer's original music works without authorisation, he added.

Opposing the plea, senior advocate Vijay Narayan, representing Sony, submitted that Sony in 2000 purchased the rights to the songs from Echo Recording Company and Oriental Records, the original copyright owners of the works. Ilayaraja received remuneration for all such compositions he made for the films, and therefore, the producer became the first owner, he said.




