The Parties shall keep each other informed on all relevant activities falling under the scope of this collaboration and shall hold regular consultations in order to evaluate the progress in implementation of this MOU, and to revise it and/or develop new plans for current and prospective activities, as deemed appropriate.
9. This MOU does not in any way commit either party to financial obligations

Article 9 - Notification and Amendments

- 1) Each Party shall promptly notify the other in writing of any anticipated or actual material changes that will affect the execution of this MOU.
- 2) The Parties may amend this MOU by mutual written agreement, which shall be appended to this MOU and become an integral part of it.
- 3) Any notice required by this MOU shall be deemed properly.

Article 11 - Termination

- 1) Each of the Parties shall have the right to terminate this Agreement, without cause, by giving the other written notice at least thirty (30) calendar days prior to the effective date of termination. It is

understood that any such termination shall have no effect on any other Agreements then in force between the Parties and that the performance of such other Agreements shall be subject to their own terms and conditions.

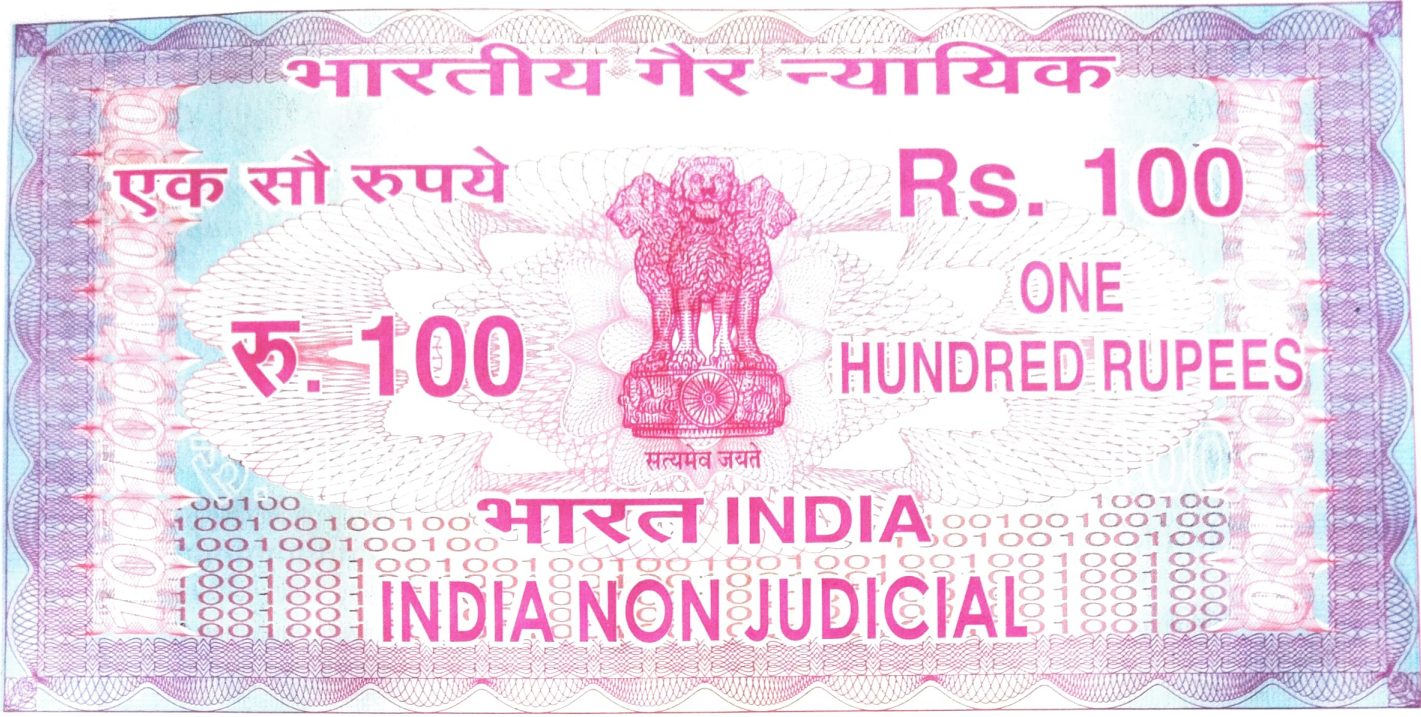

MEMORANDUM OF UNDERSTANDING (MOU)
